

### **Application for Temporary Noise Waiver**

### For Distribution by July 5, 2024

The Department of Environmental Protection is currently reviewing an application for a Temporary Noise Waiver as allowed under the Montgomery County Noise Control Ordinance, Chapter 31B, Section 11(a). The Department will receive comments on the application for a minimum of ten (10) days after distribution of this notice.

The Temporary Noise Waiver is being requested by Traffic Engineering Services on behalf of A&A Transfer, 4420 Lavin Ln, Chantilly, Virginia. A large mobile crane will be placed at 7400 Wisconsin Ave, Bethesda. The Temporary Noise Waiver will allow for continuous operations for set up and take down of the mobile crane. The weekend work will minimize impacts to residents, pedestrians, businesses, and vehicle traffic.

The work is scheduled to occur on July 20 and 21, 2024, weather permitting. The alternate date is August 3 and 4, 2024.





SIGNS SHALL BE CONSTRUCTED FROM DURABLE MATERIALS WHICH WILL NOT DETRIORATE UNDER NORMAL AND

REPEATED OUTDOOR USE.
