**SUBJECT:** Approval of Executive Regulation 12-22, Extension of the Sunset Date of the Montgomery County Personnel Regulations

**Background**


1. On August 8, 2022, the County Council received Executive Regulation 12-22, Extension of the Sunset Date of the Montgomery County Personnel Regulations. The purposes of the regulation are to extend the sunset date of the Montgomery County Personnel Regulation until September 1, 2026, and to require the establishment of a schedule to review the Personnel Regulations.
2. The Council must review the regulation under Method (1) of Section 2A-15 of the County Code.
3. Under Method (1), the Council must approve the regulation before it takes effect.
4. Executive Regulation 12-22 was advertised in Volume 39, Issue 10 of the Montgomery County Register.


