Background

- 1. On November 29, 2022, in order to clearly articulate the commitment of the County Council to racial equity and social justice, and affirm the need for racial equity and social justice in the County, the 19th Council adopted a Commitment Statement (Statement) to Racial Equity and Social Justice.¹
- 2. At the direction of Council leadership, the Racial Equity and Social Justice Core Team (Core Team)² developed for the Council's consideration an updated 2024 Commitment Statement to Racial Equity and Social Justice.
- 3. On June 13, 2024, the GO Committee voted unanimously to recommend to the full Council the approval of the 2024 Racial Equity and Social Justice Commitment Statement.

This Commitment Statement is a living, enduring statement. It captures in one place, the 20th Council's ongoing and deep commitment to transforming daily, organizational, cultural, internal, and external practices to ensure racial equity and social justice that it seeks to foster, enhance, and expand in Montgomery County.
