SUBJECT: Amendment to the Fiscal Year 2025 Operating Budget
Montgomery County Government Resolution 20-526, Section G,
Fiscal Year 2025 Designation of Entities for Non-Competitive Contract Award:
Wireless Infrastructure Association

Background

1. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and the proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2025 Designation of Entities for Non-Competitive Contract Award resolution as listed below.
2. The Chief Administrative Officer has determined that funding for the contract with this entity serves a public purpose and that such an expense would be in the public interest.
3. The Department of Technology and Enterprise Business Solutions (TEBS) will change the entity name on the contract from Wireless Industry Association to Wireless Infrastructure Association (WIA).
4. TEBS will revise the purpose of an existing contract with WIA to include, “Outreach with WIA members to support job placement of participants.”
5. TEBS will increase the award of an existing contract with WIA by \$40,500 for a revised award amount of \$255,500 for the purpose: “Provide Telecommunications Industry Registered Apprenticeship Program and similar curriculum, certifications, and related instructional support, and outreach with WIA members to support job placement of participants.”
6. Funding for this action is available through the TEBS FY25 Operating Budget, which has appropriate funds from the Department of Labor’s 5G Broadband Program grant via Special Appropriation #25-6 (Resolution 20-526). No additional appropriation is necessary.

Action

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 20-526, Section G, FY25 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that this action serves a public purpose and is in the public interest.

The FY25 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to reflect that TEBS will:

1. Change the entity name on the contract from the Wireless Industry Association to the Wireless Infrastructure Association (WIA).
2. Revise the purpose of an existing contract with WIA to include “Outreach with WIA members to support job placement of participants.”
3. Increase the award of an existing contract with WIA by \$40,500 for a revised contract award amount of \$255,500 for the purpose: “Provide Telecommunications Industry Registered Apprenticeship Program and similar curriculum, certifications, and related instructional support, and outreach with WIA members to support job placement of participants.”
