SUBJECT: Approval of the FY 2026 Aggregate Operating Budget

Background

- 1. Section 305 of the County Charter requires the affirmative vote of 8 Councilmembers to approve the aggregate operating budget if that budget exceeds the adopted spending affordability guidelines then in effect. Section 305 excludes from the aggregate operating budget:
 - Specific grants;
 - Enterprise Funds;
 - Tuition and tuition-related charges at Montgomery College;
 - Washington Suburban Sanitary Commission.
- 2. Section 20-60 of the County Code requires the County Council to set spending affordability guidelines by resolution no later than the second Tuesday in February. The guidelines must specify a ceiling on the aggregate operating budget for FY 2026.
- 3. Section 305 of the Charter requires that at least 7 Councilmembers must approve the aggregate operating budget if that budget exceeds the aggregate operating budget for the preceding year by more than the rate of inflation, as measured by the annual average increase in the Consumer Price Index for all urban consumers in the Washington-Baltimore Metropolitan area for the 12-month period preceding December 1, which was 3.25% for the 12-month period preceding December 1, 2024.
- 4. On May 23, 2024, in Council Resolution No. 20-531, the Council approved the FY 2025 aggregate operating budget in the amount of \$6,387,230,458. If that aggregate operating budget increased at the 3.25% rate of inflation for the 12-month period preceding December 1, 2024, it would be \$6,594,655,611.

5. In Council Resolution No. 20-719, adopted February 11, 2025, the Council adopted the following spending affordability guideline for the Fiscal Year 2026 aggregate operating budget:

• FY 2026 ceiling on the aggregate operating budget \$6,594,655,611
