PURPOSE: Introduction – no vote expected

Bill 9-23, Alcohol and Other Drug Abuse Advisory Council – Renamed, sponsored by Council President Glass at the request of the County Executive, is scheduled to be introduced on February 14, 2023. A public hearing is tentatively scheduled for February 28, and a worksession before the Health and Human Services Committee is tentatively scheduled for March 9, 2023.

Bill 9-23 would change the name of the Alcohol and Drug Abuse Advisory Council to the Alcohol and Drug Addiction Council. Alcohol and Other Drug Abuse Advisory Council Name Change Amendment

DESCRIPTION: Change the name to Alcohol and Other Drug Addiction Advisory Council and change the term "abuse" to

"addiction" throughout the County Code.

PROBLEM: According to professional and government entities, the

term "abuse" is harmful to addicted individuals because it stigmatizes them and their families, negates that addictive disorders are medical conditions, blames the illness solely on individuals, absolves those selling and promoting addictive substances, and has a strong association with punishment. "Addiction" is a widely

used medical term and is preferred by medical

professionals over "abuse."

GOALS AND OBJECTIVES: Changing the name of the Alcohol and Other Drug

Abuse Advisory Council and eliminating the word "abuse" to reflect preferred medical professional terminology will help to reduce the stigma associated with addiction, reverse stereotypes and improve access and support for addicted individuals and their families.

Request for Name and Language Change in the County Code

I am transmitting the proposed Bill XX-XX, requesting amendments to language throughout the County Code that the Alcohol and Other Drug Abuse Advisory Council (AODAAC) has identified as perpetuating negative bias toward individuals with substance use disorders. These revisions include updating the name of the Council itself from 'Alcohol and Other Drug Abuse Advisory Council' to 'Alcohol and Other Drug Addiction Advisory Council'.

As AODAAC's background research has revealed, national organizations, agencies, scientific journals, the press, and associations have all called for the removal of stigmatizing language like "alcoholic" "and "drug abuser", to reverse harmful stereotypes and to improve support for persons affected by the disease of addiction. Recent studies demonstrate the impact stigmatizing language can have on outcomes for individuals with substance use disorders. The National Institute on Drug Abuse (NIDA) found that reading the word 'abuse' in reference to persons with substance use disorders predisposes the reader to punitive attitudes toward such individuals.

The language revisions requested in the attached proposed amendments comport with the current recommended language for defining substance use disorders and treatments. I look forward to working with the Council to implement these important changes.

Dear Council Member Albornoz:

The Alcohol and Other Drug Abuse Advisory Council (AODAAC) requests amendment to Montgomery County Code Chapter 24, Health and Sanitation Article V, Alcohol and Other Drug Abuse Advisory Council Sections 24-41 through 24-43, replacing all mentions of the word 'abuse' with the word 'addiction'. This would include changing the name of the council itself from 'Alcohol and Other Drug Abuse Advisory Council' to 'Alcohol and Other Drug Addiction Advisory Council'. Furthermore, AODAAC requests amendments to all language throughout the County Code that stigmatizes substance use disorders, replacing the language with terms that reduce negative bias.

AODAAC is requesting these amendments for the following reasons: Firstly, certain words contained in the County Code such as 'alcoholics' have negative connotations and equate people to their diagnoses. Replacing these words with person-first language instead honors the integrity of individuals with substance use disorders as whole human beings³, more accurately reflecting the County's equity priorities. Further supporting the revisions, national organizations, agencies, 2,3, scientific journals, 4,5 the press, 6 and associations have all called for replacing stigmatizing language to reverse harmful stereotypes about addiction and to improve access and support for persons who are affected by the disease of addiction.

To better align with AODAAC's anti-stigma priorities, AODAAC requests a change from 'abuse' to 'addiction' within the AODAAC name itself. The word 'abuse' is stigmatizing because: "(1) it negates that addictive disorders are medical conditions, (2) it attributes blame for the illness to the individual, ignoring environmental and genetic factors, as well as the ability of substances to alter brain chemistry, (3) it absolves those selling and promoting addictive substances of any wrongdoing, and (4) it feeds into the stigma experienced not only by individuals with addictive disorders, but also family members and the addiction treatment field." Studies show that reading the word 'abuse' in reference to people with substance use disorders predisposes the reader to negatively judge and have punitive attitudes toward such individuals. Addiction' is a widely used medical term that replaces the word 'abuse', as does the phrase 'substance misuse'.

Below is a glossary compiled by AODAAC and informed by Words Matter³, which the AODAAC board used to inform the replacement language it requests. The phrases in the 'Revised' column comport with the current recommended language defining substance use disorders and treatments.

Behavioral Health and Crisis Services

	Current	Revised
•	Addict/ Drug Abuser	Person with Substance Use Disorder
•	Abuse	Substance use disorder, substance misuse, or addiction
•	Alcoholic	Person with Alcohol Use Disorder or alcohol misuse
•	Former addict	Person in recovery or long-term recovery
•	Relapse	Recurrence of substance misuse

An additional requested revision in the attached draft concerns language acknowledging that alcohol is itself a drug according to NIDA⁸, by using phrases like 'alcohol and *other* drugs' or 'substance use' which both include alcohol in the same category as other substances.

AODAAC respectfully requests your consideration of the County Code revisions outlined below. Thank you for your consideration.
