SUBJECT: Special Appropriation to the FY2007 Operating Budget

Montgomery County Fire and Rescue Service (MCFRS)

MCFRS program staff; Apparatus Management Plan - \$2,590,000

## **Background**

- 1. Section 308 of the County Charter provides that a special appropriation: (a) may be made at any time after public notice by news release; (b) must state that the special appropriation is necessary to meet an unforeseen disaster or other emergency or to act without delay in the public interest; (c) must specify the revenues necessary to finance it; and (d) must be approved by no fewer than six members of the Council.
- 2. On April 8, 2004, the Council received from the CAO the *Montgomery County Fire and Rescue Service Apparatus Management Plan*. In October 2004, the Council adopted Resolution No. 17-798 approving \$760,000 to implement the first two near term tasks in the plan. In December 2004, the Council adopted Resolution No. 15-850 approving \$928,240 to implement additional FY05 elements of the plan. In July 2005, the Council adopted Resolution 15-1091 approving \$2,698,260 to continue to implement the Plan in FY06. In March 2006, the Council adopted Resolution No. 15-1364 approving, among other things, \$2.5 million for one-time expenditures for MCFRS, of which approximately \$1.5 million was to buy one-time items under the Apparatus Management Plan.
- 3. The Public Safety Committee has continued to review the status of the apparatus fleet and the implementation of the Apparatus Management Plan on a regular basis. The Committee generally supports continuation of the Plan in FY07, although no funds for this purpose were included in the FY07 budget.
- 4. During the Council's review of the FY07 operating budget, it was brought to the Council's attention that certain staffing resources were needed for MCFRS to fully implement its programs, but were not included in the budget. These staffing needs include: adding personnel to staff an EMS flex unit to increase EMS capacity in areas

with heavy EMS call loads; increasing the contract Medical Director position for EMS from part time to full time; and adding a new Captain position to ensure that new training standards are implemented consistently throughout the fire and rescue service.

- 5. This special appropriation will enable MCFRS to continue to implement the Apparatus Management Plan in FY07, and to hire the personnel described in Paragraph 4.
- 6. Notice of a public hearing was given, and a public hearing was held.

## Action

The County Council for Montgomery County, Maryland approves the following action:

A special appropriation to the FY07 operating budget of the Montgomery County Fire and Rescue Service is approved as follows:
