Bill 26-20, Environmental Sustainability - Energy and Air Quality Advisory Committee - Amendments, sponsored by Lead Sponsor Council President at the request of the County Executive, was introduced on June 16, 2020. A Transportation and Environment Committee worksession was held on July 6. A public hearing was held on July 7 at which there were no speakers.<sup>1</sup>

Bill 26-20 would modify the duties and responsibilities of the Energy and Air Quality Advisory Committee as well as change the name of the Committee. The Council declared a climate emergency in adopting Resolution No. 18-974 after the establishment of the Energy and Air Quality Advisory Committee. None of the existing boards, committees, or commissions within the Office of the County Executive directly advise on climate change issues. Bill 26-20 would add advising on climate change issues to this existing Committee and change its name to the Climate, Energy, and Air Quality Advisory Committee.

The Bill would permit the existing members of the Committee to remain as members of the newly revised Committee until the conclusion of their terms of office.

## Public Hearing

## T&E Committee Worksession

Stan Edwards, DEP, and Senior Legislative Attorney Robert Drummer participated in the discussion. Mr. Edwards explained the reasoning for the Bill and answered the Committee's questions. The Committee recommended, subject to the public hearing scheduled for the following day, approval of the Bill as introduced.

## Discussion

OMB estimates that the Bill would have no impact on County revenues or expenditures. See ©7-8. OLO estimates that the Bill itself would have minimal impact on County residents and private organizations. Although the Committee may recommend actions or programs that could have a significant impact on environmental issues, OLO is unable to estimate that. See ©11-13. The County Attorney's Office found no legal issues.

Reducing the adverse impact of climate change is an important goal for the County. Adding this responsibility to the existing Advisory Committee can only help.

1 **Sec. 1. Sections 18A-1, 18A-5, and 18A-8 are amended as follows:**

2 **18A-1. Findings and statement of purpose.**

3 (a) In the interest of maintaining an adequate and reliable energy supply at  
4 reasonable cost, the County government recognizes the need to  
5 institutionalize through legislation an energy policy and energy planning  
6 program. In addition, the efficient use of energy directly benefits air  
7 quality and climate, demonstrating the linkages necessary to achieve  
8 essential environmental goals. For this reason, the responsibilities of  
9 the Advisory Committee on Climate, Energy, [Conservation] and Air  
10 Quality includes [are expanded to include] an advisory function with  
11 respect to air quality and climate change.

13 **18A-5. Climate, Energy, and Air Quality Advisory Committee; establishment;**  
14 **terms of office; ex-officio members; etc.**

15 (a) There is hereby established an Advisory Committee on Climate,

17 Executive in carrying out the purposes of this [Article] Chapter  
18 and Chapter 3. The Committee consists of 15 members appointed by  
19 the [County] Executive, subject to confirmation by the [County]

**Bill XX-20, Energy and Air Quality Advisory Committee—Amendments**

**1. Legislative Summary.**

Bill XX-20 changes the name of the Advisory Committee on Energy and Air Quality to the Advisory Committee on Climate, Energy and Air Quality, and expands its scope to include issues related to climate change. In 2017, the County declared a Climate Emergency (Resolution 18-974), but none of the existing boards, committees, or commissions within the Office of the County Executive directly advise on climate change issues. The proposed amendments will expand the name and scope of the advisory committee to include climate change topics.

**2. An estimate of changes in County revenues and expenditures regardless of whether the revenues or expenditures are assumed in the recommended or approved budget.**

**Includes source of information, assumptions, and methodologies used.**

This bill is not expected to have an impact on revenues or expenditures. It would not change the number of members on the advisory committee or the frequency of its meetings.

**3. Revenue and expenditure estimates covering at least the next 6 fiscal years.**

Not applicable. This bill would not have an impact on revenues or expenditures.

**SUBJECT:** Emergency Climate Mobilization

**Background**

1. Current global warming of approximately 1 degree Celsius has triggered cataclysmic changes to the Earth. These changes include an accelerating collapse of the West Antarctic Ice Sheet, the thawing of the Arctic permafrost, an increase in mega-droughts, heat waves, super-storms, flash flooding, the migration of mosquito-borne diseases, the melting of glaciers, polar ice-sheet collapse, coral bleaching, the mass extinction of species, ocean oxygen loss, and sea level rise.
2. Climate change will cause an increase in water and food shortages, civil unrest, state failure, civil war and terrorism throughout the world, with no region or nation being immune to these effects, including Montgomery County.
3. There is a strong consensus among scientists that greenhouse gas emissions must be eliminated in a decade at most -- with a simultaneous global effort to remove excess carbon from the atmosphere -- to stabilize at or near the 1.5 C (2.4 F) threshold believed to provide a reasonable chance for the survival of human civilization and other complex life forms on this planet.
4. The federal government, national media, and civil society, including most climate organizations, have drastically underestimated the urgency of the climate and ecological crises, failed to accept that we face an unprecedented global emergency, and relied on failed strategies of gradualism.
5. We must together implement a massive emergency global mobilization effort to successfully eliminate greenhouse gas emissions and remove excess carbon from the atmosphere.
6. Each of us has the moral duty to safeguard the planet for future generations.

7. Montgomery County has been a national leader in responding to the challenge of climate change, including establishing a goal of reducing greenhouse gas emissions in the County by 80% by 2050 compared to 2005 levels, yet now needs to do much more, much faster.

**Action**


The County Council for Montgomery County, Maryland approves the following resolution:

The Montgomery County Council calls upon the national Administration, the Congress, the State, and other local governments to join Montgomery County, to use all available powers and resources to:

1. declare a climate emergency and initiate a massive global mobilization to restore a safe climate and build a sustainable economy; and
2. transform the climate by reducing greenhouse gas emissions by 80% by 2027 and reaching 100% elimination by 2035, and initiate large-scale efforts to remove excess carbon from the atmosphere.

The Montgomery County Council calls upon the Montgomery County Executive, Montgomery County Public Schools and Maryland-National Capital Park and Planning Commission to advise the Council over the next six months on specific methods for accelerating the County's greenhouse gas emissions reduction goal.

## Environmental Sustainability – Energy and Air Quality Advisory Committee – Amendments

### SUMMARY

The Office of Legislative Oversight (OLO) expects Bill 26-20 to have a minimal economic impact on the Montgomery County economy. However, the committee has the potential to shape environmental policy in the County that could have significant economic impacts in the future, depending on the nature of the policies.

### BACKGROUND

On December 5, 2017, the Montgomery County Council declared a climate emergency and set a goal of “reducing greenhouse gas emissions by 80% by 2027 and reaching 100% elimination by 2035.”<sup>1</sup> To date, however, there is no board, committee, or commission that is responsible for advising the Office of the County Executive on climate change issues. To address this gap in advisory functions, Bill 26-20 would expand the scope of duties of the Energy and Air Quality Advisory Committee within the Office of the County Executive to include climate change issues. In line with the new duties, the Bill would also change the name of the committee to the “Climate, Energy, and Air Quality Advisory Committee.”<sup>2</sup>

The revised duties of the Climate, Energy, and Air Quality Advisory Committee would entail developing recommendations to identify and develop policies, programs, and materials to achieve the following goals:

- “meet[] the County’s greenhouse gas emission reduction goals,”
- “promote cleaner, more efficient, and more reliable energy use and practice in all segments of the community,”
- “meet air quality standards and ... promote healthy indoor and outdoor air quality,”
- “encourage voluntary participation in climate-related efforts, energy conservation efforts and air quality improvements,” and

## INFORMATION, ASSUMPTIONS and METHODOLOGIES

No methodologies were used in this statement. The assumptions underlying the claims made in the subsequent sections are based on the judgment of OLO staff.

## VARIABLES

The variables that could affect economic impacts in the County are business and household energy use and participation in climate-related, energy and air quality improvements.

---

## IMPACTS

### Businesses, Non-Profits, Other Private Organizations

Workforce, operating costs, property values, capital investment, taxation policy, economic development, competitiveness, etc.

OLO believes that Bill 26-20 would have a minimal impact on private organizations in the County. The committee could potentially recommend programs that result in greater business participation in energy conservation and other environmental programs. In which case, participating businesses could see reductions in energy-related operating costs. However, OLO is unable to anticipate the likelihood of such reductions in operating costs occurring, much less the magnitude of potential savings. OLO sees no direct connection between Bill 26-20 and the Council’s other priority areas, namely workforce, property values, capital investment, taxation policy, economic development, and competitiveness.

### Residents

Employment, property values, taxes paid, etc.

For similar reasons, OLO believes that Bill 26-20 would have a minimal impact on County residents. The committee could potentially recommend programs that increase household participation in energy conservation and other environmental programs. However, OLO is unable to anticipate the likelihood of greater household participation and its impact on employment, property values, and taxes paid.
