SUBJECT: Bill 11-21, Montgomery County Economic Development Corporation – Bylaws –

Live Video Streaming of Open Meetings

PURPOSE: Public Hearing – no Council votes required

Bill 11-21, Montgomery County Economic Development Corporation – Bylaws – Live Video Streaming of Open Meetings, sponsored by Lead Sponsor Councilmember Glass and Co-Sponsors Council President Hucker, Councilmembers Jawando, Katz, Navarro, Albornoz and Rice, was introduced on March 2, 2021. A Planning, Housing and Economic Development Committee worksession will be scheduled at a later date.

Bill 11-21 would require the Montgomery County Economic Development Corporation to adopt bylaws requiring: (1) the live streaming of certain meetings; and (2) the archiving of certain videos.

PURPOSE

The purpose of the bill is to increase the public transparency and accessibility of MCEDC meetings.

BILL SPECIFICS

Under current law, MCEDC is required to hold meetings in compliance with the State's Open Meetings Act (OMA). Thus, except when an exception under the OMA applies, MCEDC meetings are publicly advertised, open to the public, and archived through public minutes.

Under Bill 11-21, MCEDC would remain subject to the OMA. However, in addition to following the OMA, MCEDC generally would be required to broadcast its meetings through live video stream, and to archive those videos in a manner accessible to the public.

The MCEDC would not be required to broadcast meetings that are closed pursuant to the

#BroadcastMCEDC

OMA. The bill also would allow exceptions to the video requirements if:

- (A) <u>a majority of Board of Directors find that a technical problem or an</u> <u>emergency situation prevents the live video streaming of a meeting;</u>
- (B) a factor beyond the Corporation's control, including an electrical power outage or an interrupted internet connection, prevents or delays live video streaming of a meeting; or
- (C) <u>a factor beyond the Corporation's control, including a website error,</u>

 <u>makes the archive required under paragraph (2) temporarily unavailable.</u>

SUBJECT: Bill, Montgomery County Economic Development Corporation- Bylaws- Live Video Streaming of Open Meetings

Next month marks one year since many individuals in Montgomery County and across the country began working from home. Teleworking and virtual platforms have revolutionized the way we connect with family, friends and co-workers. It has also showcased the creativity of governments and organizations to make information more accessible.

On March 2, 2021, I will be introducing legislation to provide for the live streaming and archiving of the Montgomery County Economic Development Corporation's (MCEDC) open meetings. This legislation builds on efforts by Senator Cheryl Kagan and Delegate Mark Korman at the state level to ensure that meetings for governmental and quasi-governmental organizations with a significant fiscal responsibility are accessible and transparent to the public.

MCEDC acts as one of the primary agents to attract, retain and grow the business sector in Montgomery County. The organization has also served as the swift arm in ensuring the administration of County funds towards the economic needs of businesses during the pandemic. Since its inception in 2016, the County has allocated nearly \$40 million in general operating funds and special appropriations to MCEDC to fund their efforts to implement and manage the County's economic development programs. MCEDC receives 80% of the County's economic development funding, with 96% of the organization's revenue provided by County taxpayers.

Given the significant investment made by County taxpayers into MCEDC, residents should be able to easily access open meetings. Currently, if residents would like to watch MCEDC's meetings they must request an access code beforehand or wait to read the meeting notes after decisions have been made.

Constituents and organizations that advocate for transparency in government have reached out to me requesting greater accessibility so that they can monitor MCEDC deliberations and track the use of taxpayer dollars.

A year into COVID operations, we have seen technology become a great equalizer to ensure meetings are accessible to all. Considering all this, this legislation will:

- Require MCEDC's live stream all their open meetings on their website
- Maintain a public archive of all videos recorded
- These requirements do not apply if the Board of Directors find there is a technical problem, emergency situation, or factors out of their control preventing them from streaming their meeting
