SUBJECT: Categorical Transfer, FY17 Operating Budget
Montgomery County Public Schools, \$1,200,000
and Categorical Transfer, FY17 Operating Budget
Montgomery County Public Schools, Grant Funds, \$100,000

Background

1. Section 5-105 of the Education Article of the Annotated Code of Maryland provides for transfers among major categories of the Operating Budget of the Montgomery County Public Schools only with the approval of the County Council.
2. The County Council received the Board of Education's action of July 31, 2017, requesting a transfer among state categories as follows:

3. The County Council also received the Board of Education's action of June 13, 2017, requesting a transfer of grant funds among state categories as follows:

4. The Board of Education has requested authorization to make an FY17 categorical transfer to align budgeted appropriations with actual expenditures. This request would offset a deficit in Category 11, Maintenance of Plant, by transferring a surplus from Category 3, Instructional Salaries.

5. The deficit in Category 11, Maintenance of Plant, is primarily related to roofing repairs; heating, ventilation, and air conditioning projects; and an increased number of maintenance work orders.
6. The Board of Education has also requested authorization to make an FY17 categorical transfer of grant funds to align budgeted appropriations with actual expenditures in two categories as outlined above. The appropriate categories for grant expenditures must be anticipated in the budget, and transfers are necessary to reflect actual expenditure requirements of the grants projects when they differ from the budgeted projections.

Action

The County Council for Montgomery County, Maryland approves the following resolution:


The FY17 Operating Budget of the Montgomery County Public Schools is hereby amended, and a transfer of appropriation is approved as follows:
