The County Council for Montgomery County, Maryland approves the following Act:

Economic Development Strategic Plan, Administration. 2 The Executive must submit, by method 1 regulation, an economic (a) 3 development strategic plan for the County to the Council for approval on 4 or before [July 1, 2015] October 1, 2015 and each fourth year thereafter. 5 The success or progress of the strategic plan must be measurable and the 6 plan must include measures to address: 7 job creation; **(1)** 8 private sector compensation and benefits; **(2)** 9 target industries; (3) 10 target geographic areas; **(4)** 11 workforce education and training; (5) 12 growth in tax base; (6) 13 economic opportunity for residents; **(7)** 14 encouragement of entrepreneurs and small business; (8) 15 (9) land use; and 16 other actions necessary to promote economic development in the 17 (10)County. 18 19 **Expedited Effective Date.** Sec. 2. 20 The Council declares that this legislation is necessary for the immediate 21 protection of the public interest. This Act takes effect on the date on which it becomes 22 23 law.
