**Sec. 1. Section 8A-31A is amended as follows:**

(a) Established. The Cable Compliance Commission is established to adjudicate subscriber complaints [[from existing subscribers or prospective subscribers, who have requested and are eligible to receive service from the company,]] involving customer cable service or any other product or service.


(e) Ethics. Each member of the Commission is subject to Chapter 19A, except that the member [or prospective member] must file a limited public financial disclosure statement regarding any communication-related activities and interests and a full confidential financial disclosure statement.

**Sec. 4. Expiration date.** This Act expires on December 31, [2005] 2008.


